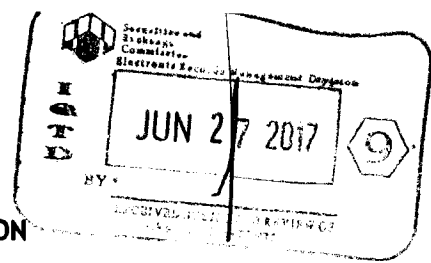

We advise that the SEC has approved the amended articles of incorporation of DMCI Project Developers, Inc., increasing the number of board seats from nine (9) to eleven (11), at least two of whom must be independent directors. Upon the foregoing, the election of Mr. Herbert M. Consunji and Ma. Cristina C. Gotianun as directors of the company, is now deemed effective. Mr. Consunji and Ms. Gotianun were elected as directors during the annual stockholders' meeting on May 4, 2017, to assume office only upon SEC approval of the company's amended articles of incorporation to increase the number of board seats to eleven. The foregoing was disclosed to the SEC through the SEC Form 17-C filed by the company on May 8, 2017. Mr. Consunji and Ms. Gotianun likewise submitted their respective SEC Form 23-A on May 8, 2017.
